Participation Conditions

By registering, the Exhibitor expressly acknowledges and agrees that the following terms and conditions governing the envisaged joint attendance at Metropolitan Solutions 2016 apply in full and are legally binding. Such terms and conditions form the legal basis for participation in the event.

General

Upon this Agreement entering into force, the Exhibitor shall be entitled to receive the following Services and to demonstrate its products and applications in the area rented by the Exhibitor.

Registration Requirements

The event is primarily aimed at manufacturing firms. The Event Organizer shall determine in its sole discretion whether an Exhibitor shall be authorized to attend, based on the relevance of its selection of exhibits to the product categorization for the event. Products which do not fall within the event's product categorization may not be exhibited except to the extent that they are strictly required in order to demonstrate and/or display any product which is exhibited in its own right. The Event Organizer shall be entitled to remove from the booth any exhibits that do not fall within the event's product categories.

Contract Formation

A complete package may be ordered via the submission of the completed registration form. The contract shall become effective when FAIRworldwide GmbH i.Gr. issues confirmation of the order.

The actual location will only be finalized upon conclusion of the planning stage on the part of the Event Organizer and accordingly may only be communicated to the Exhibitor at a later stage. If and to the extent that, 12 weeks prior to the start of the event, no space at the event can be allocated by the Event Organizer, or the number of registrations received for the shared booth falls short of the anticipated number of 12 exhibitors, FAIRworldwide GmbH i.Gr. shall be entitled to cancel the provision of the shared booth and to terminate this Agreement due to exceptional circumstances. In the event that the shared booth is not provided, FAIRworldwide GmbH i.Gr. shall notify the Exhibitor thereof without delay and FAIRworldwide GmbH i.Gr. shall refund all payments made to the Exhibitor. Any further claim by the Exhibitor resulting from failure to provide the shared booth is hereby excluded.

Scope of Supply

Complete Package

Booth concept, design, construction, registration fee, Event Organizer's booth fees (registration fee, basic rental costs, corner location supplement, marketing contribution, AUMA contribution), provision of facilities including individual presentation area, bar stool and brochure rack.

Price and Payment

The base package price is €4,750 exclusive of VAT for a basic package, €5,500 exclusive of VAT for a business package and 1,200 Euro + VAT for young enterprises that have been in business less than 5 years). The price is payable within 14 days of receipt of invoice. If and to the extent that any chargeable

additional services are ordered, a specific invoice in respect of such services shall be issued at the end of the event.

Performance/Booth layout

Modifications to the constructions of the booth, including without limitation the use of any adhesives or paint, are not permitted. The Exhibitor shall be liable for any loss or damage, howsoever arising. Presentations may only take place within the rented booth area and must be arranged so that they do not disturb adjoining booths and/or spaces (whether audibly or visually) and do not block any booth space or corridors. Individual spaces shall each be made available one day before the commencement of the event at 12:00 noon and the Exhibitor shall vacate its space in an orderly, clean and tidy state not during the first day of dismantling the booths.

Information relating to FAIRworldwide

FAIRworldwide GmbH i.Gr. shall notify the Exhibitor via e-mail in respect of any updates relating to the preparation or implementation of the shared booth space. The Exhibitor shall be solely liable in respect of any consequences arising from any failure to adhere to the content of such e-mail.

Early Termination of the Contract

In the event that the Exhibitor terminates this Agreement prematurely, the Exhibitor shall be liable to the Event Organizer for the following liquidated damages:

12 weeks or more prior to commencement of the Event: 25% of the event fee

8 weeks or more prior to commencement of the Event: 50% of the event fee

Less than 8 weeks prior to commencement of the Event: 100% of the event fee

Any cancellation must be expressed in writing. The date on which any cancellation or termination is received by FAIRworldwide GmbH i.Gr. shall determine the level of liquidated damages payable. In the event that the Exhibitor terminates or cancels the Agreement, the Exhibitor shall be invoiced for any specialist visitor tickets ordered and issued in its name, regardless of when the termination or cancellation becomes effective.

Insurance and Liability

The Exhibitor shall be liable for all claims in respect of death, personal injury or loss or damage to property suffered by any third party as a result of its participation in the Event, including, for the avoidance of doubt, any loss or damage to the event premises or showgrounds. In accepting these Participation Conditions, the Exhibitor expressly agrees to indemnify and hold harmless the Event Organizer, FAIRworldwide, in respect of any third party claims.

Severability

In the event that any provision of this Agreement is found to be invalid or unenforceable, or should it become so after the effective date, the remaining provisions of this Agreement shall continue in full force and effect. Any invalid or unenforceable provision shall in such circumstances be replaced by a valid and enforceable provision, in order to bring about as nearly as possible the commercial position represented by the invalid or unenforceable provision as agreed between the Parties. The Parties shall similarly agree to give effect to the commercial agreement between the Parties in the event that any lacunae in the Agreement are revealed.
